- . Requestors will be notified via email when the report is ready to be viewed. Once available, the report can be downloaded in PDF form.
- Requestors will need Adobe Reader to view and print the results <u>Click here to download</u>

- + If the report contains an error in your criminal record, you can challenge the report.
- Results are reflective of NH Criminal Conviction Record Information at the date and time of request.
- . Results will return certified adult convictions only at the time of the request.
